This certificate of registration does not constitute any statutory permission/ license to the Society to undertake Aims/ Objectives as specified in the byelaws/ constitution filed in this office, which, however shall be subject to the production of NDCs/ Licenses, required if any, under any other law/ statute of the Government (Centre/ UT).
3. The document certifies registration under Society Registration Act 1860 only. However, any Govt. / any other association/ person may make necessary verification (on their own) regarding the conduct, assets & liabilities etc of the society before entering into any contract/ assignment with the instant society.
4. The society shall not be entitled to use it's translated/ abbreviated/ acronym name and shall use the registered name only clearly indicating that it is governed by private body/ society and not by the Government.
5. Further, the society shall not be used for any commercial or trade or business purposes or profession certification/ affiliation/ recognition to other organization.
6. Under no circumstances shall the society change its registered name, members, location, constitution byelaws etc except with the prior approval / permission of the Registrar of Societies Kashmir.
