Highlights of the Weeks Ending 14th & 21st March, 2016:

- briefed the house on 21st, about the case of Shri Mohan Lal Sharma who retired on superannuation in 1993 from All India Radio as Sr. Engineering Asstt. He had been pursuing his case, for a long time, of his pension revision in terms of OM dated 28.1.2013, seeking benefit of Grade Pay allowed to the Pre-1995 pensioners w.e.f. 24.09.2012. Later this benefit was awarded from 1.1.2006 as per OM dated 30.7.2015. His grievance was lodged in CPENGRAMS of the PensionersqPortal by the Association on 24th Oct 2015 and the case was disposed off by CPAO Office on 18.3.2016 i.e. after 5 months time. In the resolution the CPAO Office has referred to Pension Revision advice dated May, 2013 and sent to his Bank (SBI Janipur Branch, Jammu) for the needful action. For this simple communication, CPAO has taken 5 months. No copy has been endorsed to the Pensioner and the Bank also has not bothered about the revision.
- Action by Association: This is just one example how things are going, especially in case of unaware and aged pensioners. A letter has been written to the Bank with all relevant downloads for prompt action in the matter. It is a fit case to fix responsibility for casual treatment resulting in huge financial loss in lacs to the old pensioner. The Association will pursue the matter further as necessary.
- Grant-in-aid by the Governor: Honφle Governor, Jammu & Kashmir State has very kindly acceded to our request submitted in a letter dated 25th Janury, 2016 and released a grant of Rs. 1.00 lac for the promotional and welfare activities of the pensioners. Letter of thanks has been submitted to the Honφle Governor on behalf of the Association on 8th Mar 2016.
- Weekly Talk: An informative talk was delivered by Mr. O.P.Vidyarthi, IFS, Director, Environment & Ecology, J&K, Jammu on 21st March, 2016 to commemorate International Day of Forests.
